**DECLARATION OF WITHDRAWAL**

Pursuant to Section 8.4 of the Declaration of Covenants, Conditions, Restrictions and Easements for Blossom Rock, recorded June 24, 2022 as Fee Number 2022 072799, in the official records of Pinal County, Arizona (the "Community Declaration"), and Section 11.4 of the Declaration of Covenants, Conditions, Restrictions and Easements for Blossom Rock Residential Community, recorded June 24, 2022 as Fee Number 2022 0727800, in the official records of Pinal County, Arizona (the "Residential Declaration"), the undersigned, being the Community Declarant under the Community Declaration and the Residential Declarant under the Residential Declaration, and with the consent of the owner of the real property legally described in Exhibit "A" attached hereto (the "Withdrawn Property"), hereby withdraws the Withdrawn Property from the terms and conditions of the Community Declaration and the Residential Declaration. Accordingly, effective upon the recording of this Declaration of Withdrawal, the Withdrawn Property and its owner shall no longer have any of the rights, benefits and easements described in the Community Declaration, or the other Community Documents (as defined in the Community Declaration), or the Residential Declaration, and shall no longer be subject to any of the obligations, burdens and liabilities described in the Community Declaration, or the other Community Documents, or the Residential Declaration.
